1. Apologies for Absence and Quorum – Meeting was quorate, apologies from Cllr S Dorey.
2. Review of and Approval and signature of previous meeting's minutes (14.9.22) – Reviewed and signed.
3. Members Declarations of Interest on any Agenda items – Cllr Couldrake - Planning application WNS/2022/1951/TCA.
4. Questions from Parishioners in attendance (note 3 minutes per parishioner) - none
5. West Northamptonshire Council Report – Cllr Grant
  - i) A428 proposed 50mph limit - notice on consultation expected imminently.
  - ii) Stagecoach 41 Bus Route – unexpected cutting of this critical route. Usage did not pick up after pandemic. Negotiations on going. Cllrs Nelson and Turner are attending further meeting. (Date to be arranged).
  - iii) Billing Road – pleased to see action is being taken on exploration of traffic calming schemes.
  - iv) Ward Boundary Review – proposals being made to be to government in time for elections in 2025. Consultation in January 2023. Chairman asked the Councillors what their views are on one of the proposal for of a ward boundary consisting of the A428 villages, Hackleton, Piddington, Roade, Blisworth Hartwell and all were in favour of combining similar rural villages.

## 6. Planning Applications for comment (see annexed list)

WNS/2022/2130/FUL – PC - Should be looked at with heritage content – and make a report on its historical usage.

WNS/2022/1951/TCA – PC - no comment

WNS/2022/1816/FUL – PC - Concern that extension would not be sympathetic to immediate vicinity and should be of stone construction, thus in keeping with neighbouring properties some of which are Grade 2 listing.

## 7. Estate Matters:

- Footpaths – any issues for report – nothing to report
- Street lighting – light in Billing Road, Cllr Allingham will request Cllr Dorey checks it out.
- Play Area – update, any health and safety concerns, Annual inspection report has been received and circulated – Volunteers may be sought to weather treat benches. No significant issues raised.  
Cllr Allingham reported that the Jubilee Committee is putting the seat in the play area which had been destined for Grove Road for which another one will be installed. Both will be in by January 2023, installation by Jason Smith. The slabs are in place in the Play Area. The new toddler swings are being paid for by the Poors Land Trust and should also arrive early in 2023.
- Litter bins – have not arrived yet, **Clerk** to chase up
- Cllr Turner had contacted Mowerman and new grit bin should be installed in a couple of weeks.

## 8. Highways

- Updates on Fix my Street reports –
- On-going issue of vegetation growing over village sign on A428 (reported to Fix My street) – work done (further to Billing Road meeting with Matthew Clarke)
- Review of WNC verge cutting – Cllr Allingham reported that Brafield Wombles have carried out litter pick, cleared drains and removed vegetation from signs.  
Cllr Copsey expressed concerns that verges are not cut to the same extent in the villages as in the town? Cllr Copsey will report.
- Bridle Path – 2 cycling sign in need of replacement – **Clerk** to report to Fix my Street - Order no 4 made in 1954. (Reported ref 3971497)
- Billing Road traffic calming – Chairman reported that a constructive meeting took place on 23.9.22. with Highway Officers. Stephen Barber to visit Billing Road and advise on *mobile* VAS devices including

costings. **Cllr Allingham** will write application for VAS funding and circulate. Will then invite police to make a report. Dragons teeth and gateway might be considered as well. Council could add funds to make scheme more viable. May be innovative technological equipment which could also be used to detect lorries etc.

Football parking in Church Lane has been raised again - Irritation being caused and tractors cannot always get past.

There are some players from the village. Difficult to resolve.

Cllr Morgan will write to the Club leader and request considerate parking. The Chairman will speak to the Arrowsmiths.
