- Speeding issues in Billing Road

Further to correspondence from resident a site meeting is to be held on 23rd September with Community Highways Liaison Officer – Matthew Clarke. Cllrs Nelson, Turner, Allingham and Couldrake to attend. Facebook invitation to go out to villagers. Speeding and use of the road by lorries will be focus. Historically a chicane was not allowed on Billing Road due to size of public bus but now Village Hopper is used the proposal could be re-visited. Cllr Nelson will ask for evidence from residents on issues in the road. Cllr Turner will produce fliers to advertise the meeting.
