1. **Apologies for Absence and Quorum** – Mr M Andrews
2. **Review of and Approval and signature of previous meeting's minutes (18.9.24).** – Minutes agreed and signed by the Chairman.
3. **Members Declarations of Interest on any agenda items** – none
4. **Questions from Parishioners in attendance** (note 3 minutes per parishioner) –none

Cllr Grant :

- Will enquire as to why there has been a pause in the installation of the dragon's teeth and gateways. Will also raise the issue of one of the gateway's position.
- Northampton market now open – successful opening

7. **Estate Matters:**

- Footpaths – any issues for report – will need to recruit another Footpath Warden
- Street lighting – any issues for report – streetlight at the Pond is now working. One at the corner of Horton Road is to be repaired.

8. **Pond Repair** – pipe work complete apart from jet washing - all within the budget. Ownership of pond still under review. The Chairman will look into this matter.

- 9. Play Area** – update – Inspection Report circulated – any risks identified were low or very low. **Clerk** to arrange replacements of a few items with Wicksteed. Cllr Copsey reported that the hedges adjacent to gardens are very long and need to be cut by Green Leaf Gardening, **Clerk** to request.

10. Highways

- Updates on Fix my Street reports – message sent to Fix my Street for damage to Green to be repaired.
- Billing Road – traffic calming, VAS device and dragon’s teeth + gateway – Update – work progressing although there has been a pause in installation of gates.
- Cllr Copsey reported grit bins need filling. **Clerk** to contact Mowerman to request delivery and filling of the 3 bins owned by the PC.
- Billing Rd – pause in installation of gateway being looked into by Cllr Grant.
- VAS machine – Chairman hopes a group of volunteers will come forward to help in moving it to various sites and replacing batteries. Will put this out on Facebook, the newsletter, the Working Men’s Club and the shop. One volunteer was in attendance at the meeting and was willing to lead the Billing Road group.
- Cllr Allingham suggested using cardboard cut-outs of children and bin stickers as a deterrent to speeding. She will get quotes for these for the **next meeting**.
- Walk around the village with WNC – Chairman will contact Cllr Grant to pursue this.

- 11. Verge mowing in the village** – Council to consider signing up to the 136 Parish Grass Cutting Scheme. WNC would pay the Parish Council the equivalent cost of 3 cuts per year - £955. After discussion it was agreed that this should be pursued.

It was agreed that the Chairman will contact Helen Howard and request map of where WNC cut at present. Will then approach existing grass cutters for quotes.

- 12. Dog bins** – Council to consider cost of installation and emptying of dog bins. A quote had been obtained - £175 to install a bin and £200 per year to empty it. It was felt 3 would be required. After further discussion it was agreed not to have dog bins, but encourage people to take the poo bags home.
