1. **Apologies for Absence and Quorum** – Cllr F Copsey
2. **Review of and Approval and signature of previous meeting's minutes** (15.1.25). – Minutes agreed and signed by the Chairman.
3. **Members Declarations of Interest on any Agenda items** – Cllr Allingham declared interest in item 16
4. **Questions from Parishioners in attendance (note 3 minutes per parishioner)**
A resident enquired about the purchase of the VAS device. The Chairman informed her that a grant had been obtained to cover the cost.
A resident asked whether anything could be done to encourage people not to go through a gap in the hedge from Owen Court as a shortcut across private land to the footpath to the church. The response was that this was not within the remit of the Parish Council. The same resident may be interested in becoming a footpath warden and will discuss this with the Chairman.
5. **West Northamptonshire Council Report – Cllr Clarke reported**
 - Advised Council to report highway/footpath/flooding issues to Fix my Street.
 - Cllr Morgan stated that the PC needs WNC to ensure support for the Stagecoach service and the Village Hopper.
6. Parish Council Election/Nomination Process. Clerk and Chairman will hold Electoral Register for elector numbers. Nomination forms to be submitted by April 2nd.
7. **Consideration of and approval of a variation to the lease of the Alley Lane Playground** – The Church and Poors Land Trust wish to sell a small area of land - 27.5m², as part of a transaction involving the sale of the adjacent Alley lane and garden ground behind 2 Church Lane. The Chairman had met with the Trustees on site and received correspondence from a

Trustee requesting agreement to the land in question being removed from the lease. The Parish Council agreed to the request and the letter was signed and dated by the Chairman and Clerk to record the change.

13. Billing Road – traffic calming, VAS device update – analysis of data

Cllr Dorey reported. Cannot download and monitor at the same time. Promising in that not many people are going above 32mph. Residents have noticed a decrease in speed and noise. Now located to Bedford Road. Will collate information and make a report. Next location is Horton Road.

14. Verge mowing in the village – Council to prioritize which verges require mowing by Parish Council

Unable to get information from WNC on what areas they cut. Council discussed whether to take grant and cut what the Parish Council wants? It was agreed for Chairman to contact Brown and Barden to see if they will quote for cutting area next to Village Sign. Clerk to send contractor's details to Chairman.

15. Litter / Dog bins – Chairman reported back on the meeting on 16.1.25 with Mr Dan Johnson Street Cleansing Supervisor from WNC. Very helpful useful meeting. WNC will empty 3 new bins. Bin on Billing Road has been removed because it was broken, consequently PC bin is being well used. Cllr Nelson has been monitoring this.
